

Consent Video License Agreement

This Agreement will be governed by and interpreted under the laws of the State of Texas, without giving effect to applicable conflicts of law principles. Except as expressly provided herein, this Agreement may not be amended or modified by the parties in any manner, except by an instrument in writing signed on behalf of each of the parties to which such amendment or modification applies by a duly authorized officer or representative.
